# **Official Rules**

### How to Gain Entry:

- 1. Participants must have a Muckleshoot Bingo Players Club card.
- 2. All participants must be 21 years of age or older.
- 3. Participants must sign up prior to the tournament starting at 3 pm, Friday, April 5, 2024.
- 4. Registration is located in Game Room 5 at the TournEvent station located just outside Twin Rivers Bar.
- 5. There is a maximum headcount cap for this Tournament set at 100 participants.
- 6. Participants will be entered on a first-come first-served basis. Once the maximum number of players is reached, no other players will be admitted into the tournament.
- 7. This is a Free Tournament that will come at zero cost to the participant.
- 8. Participants may only participate in one (1) round of the tournament (unless advancing to further rounds). Multiple entries will not be allowed.

<u>Entry Exclusions</u>: Muckleshoot Bingo (MIB) employees are NOT eligible to participate in this promotion or be selected as a winner.

## How to Play/Win:

- 1. The first round will begin at 4:00pm, with an additional final round to follow.
- 2. Participants' round and seating assignment will be determined by the Multimedia TournEvent system, players will find their name located at the top of the gaming machine for seating assignment.
- 3. There will be a maximum of 10 sessions with 10 players in each session for the first round.
- 4. Once the first 10 sessions have been completed, the top 10 scores from all sessions combined will advance to the second and final round.
- 5. The final 10 winners from the final round will be awarded either a cash or free play prize based on order of top scores.
- 6. In the event of a 'Tie' score, the winners will face off in an additional playoff round to see who remains in that position. The loser of the tie will fall one place below.
- 7. Each session will be one (1) minute in length of VGD TournEvent play.
- 8. All participants' scores from the tournament are originated by the TournEvent system from highest score to lowest score.
- 9. All scores will be kept and tallied by the TournEvent system.
- 10. Participants who sign up but fail to show at time of play will be given a 2-minute warning announced on in house PA system. If the player fails to show after the 2-minute warning the round will begin without that player.
- 11. If participant fails to show up for the final round after the 2-minute warning, the player with the next highest score will take their place, which will continue until a player is found or 10 minutes have passed.

- 12. Winning participants must have a valid ID and Players Club card to claim their cash prize.
- 13. Participant(s) who wins the Mariners Tickets must provide a valid ID, Players Club card, phone number, and valid email address, and complete an electronic ticket transfer within the next 5 days to receive their prize. If the winning participant fails to complete the ticket transfer within 5 days, they will forfeit their prize and the 2nd Place winner will win the tickets. The 2nd Place winner will then have 5 days to complete the ticket transfer. If the 2nd place winner fails to complete the ticket transfer within 5 days, the tickets will go to the next place winner and follow the same 5-day process until the tickets have been successfully transfered.

  - 7<sup>th</sup> Place: \$125 Cash
  - 8<sup>th</sup> Place: \$100 Cash
  - 9<sup>th</sup> Place: \$75 Cash
  - 10<sup>th</sup> Place: \$50 Cash

### **General Rules:**

- 1. All Participants must show their Preferred Players Card and proper ID to be verified.
- 2. All games/rule inquiries will be handled by the VGD Department. Their decision/ruling on any matters within the promotion will be deemed final.
- 3. The Muckleshoot Indian Tribe, any other contest sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use or enjoyment of prize(s), or damages or losses related to the contest.
- 4. The Tribe reserves the right to postpone, suspend, or terminate the promotion or amend the rules at any time without notice to participants.
- 5. By entering or participating in the promotion, participants grant Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness, or voice for promotional purposes without further compensation or permission.
- 6. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes unless expressly stated in the contest rules is not permitted, provided that, in the event that the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties
- 7. Winners of promotional contests will be required to present valid photo identification acceptable to the Tribe, social security number, and complete a winner log form before a promotional contest prize will be awarded. Failure to provide required identification and complete required winner log form may result in forfeiture of promotional contest prizes.

- 8. Participants acknowledge that Prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive and IRS Form 1099.
- 9. For promotional contests that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Bingo to participate on their behalf.
- 10. Participants are responsible for hearing contest announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to contest announcements. In promotional contests involving a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
- 11. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
- 12. The Tribe is not responsible for inability to enter a drawing due to long lines or other causes.
- 13. Muckleshoot Bingo (MIB) Employees who are eligible to play bingo or VGD machines as outlined in the personnel policies are eligible to play during the promotional timeframe; however, MIB Employees are NOT eligible to participate and win in VGD tournaments, drawings of any kind, giveaways, Hot Seat promotions, Free Play promotions, and select discount and coupon offers. Always check the How to Gain Entry/Win sections of the official rules for specific exclusion information.
- 14. Entries are not transferable.
- 15. Violation of contest rules may result in disqualification.
- 16. Muckleshoot Bingo house rules apply.
- 17. In case of power interruption, the TournEvent system may interrupt play on an active session. Scores may reset back to beginning points/money total participant began the session with. As a result, those session's participants must replay the round.
- 18. Any Participant dissatisfied with a decision/ruling in this tournament may, within thirty (30) days of the disputed decision/ruling submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission.
