



## Can-Am & Cash Giveaway

**Earn Unlimited Entries:** November 1<sup>st</sup>, 2022, at 6 am through November 30<sup>th</sup>, 2022, at 10:30 pm

**Get One Free Entry:** Wednesday, November 2<sup>nd</sup>, 2022, from 1 pm - 3 pm

**Prize Drawings:** Wednesday, November 30<sup>th</sup>, 2022, every hour between 3 pm - 11 pm

### How to Gain Entry into Drawings:

1. Participant must be at least 18 years of age to participate.
2. MIB Employees are eligible to play during the designated time frame but are not eligible to win. Employees should not enter drawing tickets into the drawing barrel. If an employee does enter, their entry will be voided.

### **Earn Unlimited Entry Tickets**

1. Participant must play any AGS machine starting November 1<sup>st</sup> at 6 am until November 30<sup>th</sup> at 10:30 pm.
2. Each time the Participant wins \$50 in credits on a single spin on any AGS machine, a drawing entry ticket will print.

### **One Free Entry Ticket**

1. To gain one free entry, participants must visit the Player's Club on Wednesday, November 2<sup>nd</sup>, 2022, between 1 pm – 3 pm and present their Players Club Card and ID.
2. Only one free entry, per participant for this promotion.

### How to Play/Win:

1. Participant must retain drawing entry tickets until the drawing day (11/30/22).
2. On November 30<sup>th</sup>, participant must legibly fill out full name and phone number on each entry ticket and then deposit their completed entry tickets into the large drawing drum located in the North Lobby.
3. On November 30<sup>th</sup>, Muckleshoot Bingo will randomly draw 1 (one) entry from the drum each hour between 3 pm – 11 pm.
4. The name listed on the randomly drawn entry ticket will be verified by another MIB employee to confirm the name of the Winning Participant. Once the name has been verified, the name of the Winning Participant will be announced over the in-house PA system.
5. Participant **must** be present to win and must claim the announced prize within 5 minutes of their name being called. If Winning Participant does not report to the players club within 5 minutes, another Winning Participant will be drawn.
6. Participant can have unlimited entry tickets.
7. Participant can win multiple prizes.
8. Participant does not have to be playing with their Players Club Card.
9. Participants must have a valid ID and VIP card to claim their prize.
10. Participant must **clearly** print name and phone number on ticket. If name/number cannot be verified MIB will draw another ticket.

### **General Rules:**

1. The Muckleshoot Indian Tribe, any other contest sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use or enjoyment of prize(s), or damages or losses related to the contest.
2. The Tribe reserves the right to postpone, suspend, or terminate the promotion or amend the rules at any time without notice to participants.
3. By entering or participating in the promotion, participants grant Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness, or voice for promotional purposes without further compensation or permission.
4. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes unless expressly stated in the contest rules is not permitted, provided that, in the event that the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
5. Winners of promotional contests will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a promotional contest prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of promotional contest prizes.
6. Participants acknowledge that Prizes may be subject to tax withholding under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive and IRS Form 1099.
7. For promotional contests that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino or Bingo to participate on their behalf.
8. Participants are responsible for hearing contest announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to contest announcements. In promotional contests involving a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
9. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
10. The Tribe is not responsible for inability to enter a drawing due to long lines or other causes.
11. Employees of Muckleshoot Bingo who are eligible to play bingo or VGD machines as outlined in the personnel policies are eligible to play during promotional timeframe. See Official Rules for any specific exemptions.
12. Entries are not transferable.

13. Violation of contest rules may result in disqualification.
14. Muckleshoot Bingo house rules apply.
15. Any guest dissatisfied with a decision/ruling in this promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission.
