



**Twin Rivers Hit a Homer: Mariner Press and Diamond Club Ticket Giveaway**  
**Earn Unlimited Entries:** From 2 pm – 10 pm every Sunday, Monday, and Tuesday, April 1<sup>st</sup> – 30<sup>th</sup>  
**Earn One Free Entry:** Wednesdays in April 2024 from 1 pm – 3 pm at the Players Club  
**Grand Prize Drawings:** Wednesday, May 1<sup>st</sup>, 2024 | 5pm, 5:30pm, & 6pm

### **How to Gain Entry:**

1. Participants must be at least 21 years of age to participate and have a valid/working email address and phone number.
2. Participants must purchase two (2) individual alcoholic beverages at Muckleshoot Bingo's Twin Rivers Bar during the designated time frame to earn one entry ticket: From 2 pm – 10 pm every Sunday, Monday, and Tuesday, April 1<sup>st</sup>– 30<sup>th</sup>, 2024.
3. Each time a participant meets the above requirements, they will be issued an entry for the grand prize drawings.
4. To gain one free entry, participants must meet the requirements of rule #1 above and visit the Players Club on a Wednesday in April between 1 pm – 3 pm and present their Players Club card and ID. Only one free entry per participant for this promotion.
5. Participants must retain and save their entry ticket(s) until the drawing date, Wednesday, May 1<sup>st</sup>, 2024 (see section "How to Play/Win" Rule #1 for complete details on how to enter the grand prize drawings).
6. Lost or damaged entry tickets will not be replaced. No duplicate or copied entry tickets will be accepted.
7. Participants may earn unlimited entries, but they can only receive up to two (2) entry tickets per day (total of four (4) drinks).
8. Drawing winners will receive two (2) tickets to see the Mariners in the Press Club or Diamond Club section plus a parking pass for the games listed in the Pay Table section.

***Exclusions:*** Muckleshoot Bingo Employees are NOT eligible to participate in this promotion or win a prize drawing and must not enter. If an employee should be drawn as a prize winner, their entry will be voided and another winning entry will be selected.

### **How to Play/Win:**

1. On Wednesday, May 1<sup>st</sup>, starting at 11:00 am and ending at 5:55 pm, the participant must deposit their completed entry tickets into the clear ticket drawing bin located at the Muckleshoot Bingo Players Club:

- a. Participant must clearly print their first and last name, email address and phone number on every ticket they enter into the clear ticket drawing bin. If the name is unreadable or required fields are left uncompleted, MIB will draw another winning ticket.
2. At 5 pm, 5:30 pm, and 6:00 pm on Wednesday, May 1<sup>st</sup>, Muckleshoot Bingo will randomly draw 1 (one) entry from the clear ticket drawing bin located at the Players Club to win the corresponding game tickets as listed in the Pay Table section of these rules.
3. The winning participant's name will be verified by another present MIB employee. Once the name has been verified, it will be announced over the in-house PA system.
4. The winning participant must be present to win and must claim their prize at the Players Club within 5 minutes of their name being called. If the winning participant does not report to the Players Club within 5 minutes, another winning participant will be drawn.
5. Participants must have a valid ID, social security number, and email address to claim their prize.
6. Once the winning participant has been verified, the participant's winning entry ticket will be removed from the drawing box.
7. The winning participants must successfully complete an electronic ticket transfer by Wednesday, May 8<sup>th</sup> at 1pm or they will forfeit their prize. If the tickets remain unclaimed after that deadline, MIB will redraw a winner from the original drawing bin and the winner will be notified using the phone number they listed on the original entry ticket; they will then have 24 hours to confirm their email address and successfully claim their transferred tickets. This redraw process will continue until a winner successfully claims the tickets.
8. Participants may have unlimited entries but may only win one (1) drawing.

### **General Rules:**

1. The Muckleshoot Indian Tribe, any other contest sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use or enjoyment of prize(s), or damages or losses related to the contest.
2. The Tribe reserves the right to postpone, suspend, or terminate the promotion or amend the rules at any time without notice to participants.
3. By entering or participating in the promotion, participants grant Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness, or voice for promotional purposes without further compensation or permission.

4. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes unless expressly stated in the contest rules is not permitted, provided that, in the event that the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
5. Winners of promotional contests will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a promotional contest prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of promotional contest prizes.
6. Participants acknowledge that Prizes may be subject to tax withholding under applicable federal regulations and that payouts may be reduced due to withholding requirements. Muckleshoot Bingo (MIB) Employees who are eligible to play bingo or VGD machines as outlined in the personnel policies are eligible to play during the promotional timeframe; however, MIB Employees are NOT eligible to participate and win in VGD tournaments, drawings of any kind, giveaways, Hot Seat promotions, Free Play promotions, and select discount and coupon offers.
