



Baseball Bonanza Mariners Tickets Giveaway

Earn Unlimited Entries: June 1 – 29th, 2024

Earn One Free Entry: Tuesdays in June from 1pm - 3 pm at the Players Club

Prize Drawings: Baseball Bonanza Bingo Marathon Session, July 29th, 2024 starting at 6:40pm

Overview:

Participants will earn one entry with each minimum \$25 bingo buy-in June 1 – June 29, 2024, for the Mariners Ticket Giveaway during our Baseball Bonanza Bingo Marathon on Saturday, June 29th at 6:40 pm. Participants must buy-in for the Baseball Bonanza Bingo Marathon in order to qualify for the drawings.

How to Gain Entry:

1. Participants must be at least 18, have a Muckleshoot Bingo Players Club card, and have a valid/working email address and phone number.
2. Beginning June 1st, 2024, until June 29th, 2024, with each minimum \$25 Bingo buy-in participants will receive one (1) physical drawing entry ticket at the Admissions window.
3. To gain one free entry ticket, participants can visit the Players Club on a Tuesday in June from 1 pm - 3 pm and present their Players Club card and valid ID.
4. Participants must retain their entry tickets until the drawing date, Saturday, June 29th.

Entry Exclusions: *Employees of Muckleshoot Bingo are NOT eligible to participate in this promotion or win a drawing and are not allowed to enter. Should a MIB employee be selected as a winner, they will forfeit the prize and another winning entry will be selected.*

How to Play/Win:

1. Participants must have clearly printed their first and last name, and phone number, on their drawing entry ticket(s) before they are deposited into the drawing drum located in front of the caller stand.
2. The entry tickets must be deposited into the drawing drum by 8 pm on June 29th, 2024. Entries not placed in the drawing drum on the designated day have no cash value.
3. A Bingo buy-in receipt for the June 29th Baseball Bonanza Bingo Marathon session is required to participate in the drawings.
4. Entries are non-transferable.
5. Participants can have unlimited entry tickets.
6. Muckleshoot Bingo will randomly draw 6 (six) entries from the drum throughout the bingo session. Once the session has ended, all remaining entries in the drum will be discarded.
7. The name listed on the randomly drawn entry ticket will be verified by another MIB employee to confirm the name of the Winning Participant. Once the name has been

verified, the name of the Winning Participant will be announced over the in-house PA system.

8. Participants must be present to win and must identify themselves to a Live Bingo employee within 5 minutes of their name being called. If Winning Participant does not identify themselves within 5 minutes, another winning participant will be drawn.
9. The first winning participant drawn will get to select the set of Mariners' tickets they would like from the prizes listed in the pay table below. Once a set of tickets has been selected it will no longer be available as a prize. Each consecutive winner will get to select their tickets from the remaining prizes available until all of the prizes are claimed.
10. Participants may only win one (1) pair of Mariners tickets. If a winning participant's name is drawn again, it will be removed from the drawing bin and another winner will be selected.
11. Winning participants must have a valid ID and Players Club card to claim their prize. They must also provide a valid email address and successfully complete an electronic ticket transfer by Friday, July 5th, 2024, at 1pm or they will forfeit their prize. If the tickets remain unclaimed after that deadline, MIB will redraw a winner from the original drawing bin and the winner will be notified using the phone number they listed on the original entry ticket; they will then have 24 hours to confirm their email address and successfully claim their transferred tickets. This redraw process will continue until a winner successfully claims the tickets

2. One (1) Pair of Diamond Club tickets to see the Mariners vs Tigers, Wednesday, August 7 + Parking Pass (Valued at \$956)
3. One (1) Pair of Diamond Club tickets to see the Mariners vs Rays, Monday, August 26th + Parking Pass (Valued at \$956)
4. One (1) Pair of Press Club tickets to see the Mariners vs Mets, Friday, August 9th + Parking Pass (Valued at \$856)
5. One (1) Pair of Press Club tickets to see the Mariners vs Giants, Saturday, August 24th + Parking Pass (Valued at \$856)
6. One (1) Pair of Press Club tickets to see the Mariners vs Rangers, Friday, September 13th + Parking Pass (Valued at \$856)

General Rules:

1. The Muckleshoot Indian Tribe, any other contest sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use or enjoyment of prize(s), or damages or losses related to the contest.
2. The Tribe reserves the right to postpone, suspend, or terminate the promotion or amend the rules at any time without notice to participants.
3. By entering or participating in the promotion, participants grant Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness, or voice for

promotional purposes without further compensation or permission.

4. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes unless expressly stated in the contest rules is not permitted, provided that, in the event that the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties
5. Winners of promotional contests will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a promotional contest prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of promotional contest prizes.
6. Participants acknowledge that Prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. In promotional contests involving a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
9. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
10. The Tribe is not responsible for inability to enter a drawing due to long lines or other causes.
11. Muckleshoot Bingo (MIB) Employees who are eligible to play bingo or VGD machines as outlined in the personnel policies are eligible to play during the promotional timeframe; however, MIB Employees are NOT eligible to participate and win in VGD tournaments, drawings of any kind, giveaways, Hot Seat promotions, Free Play promotions, and select discount and coupon offers.
